

The following Ordinance was submitted for introduction by Mark Atzenhoffer in regular session convened on August 10, 2004:

PROPOSED ORDINANCE

The following Ordinance, having been previously introduced and published, was offered for final adoption by Brent Callais, seconded by Mark Atzenhoffer:

ORDINANCE NO. 3496

AN ORDINANCE TO AMEND AND RE-ENACT SECTION 2:200(A), SUB-CHAPTER "C" OF CHAPTER 2 OF THE CODE OF ORDINANCES OF THE PARISH OF LAFOURCHE AS IT PERTAINS TO THE MEETINGS OF THE LAFOURCHE PARISH COUNCIL.

BE IT ORDAINED, by the Lafourche Parish Council convened in Regular Session on October 12, 2004, that:

SECTION 1. Section 2:200(A) of Sub-Chapter "C" of Chapter 2 of the Code of Ordinances of the Parish of Lafourche as it pertains to the meetings of the Lafourche Parish Council is hereby amended to read as follows:

SECTION 2:200 MEETINGS OF THE PARISH COUNCIL

A. Regular meetings of the Lafourche Parish Council will be held on the second and fourth Tuesday of the month at 5:30 p. m., eliminating Standing Committees, in the Council Meeting Room at the Barrios Center Building in Raceland, Louisiana. By a favorable vote of at least five (5) members, regular or special meetings may be held at other locations within the Parish of Lafourche.

SECTION 2. If any section, part, paragraph, sentence, or clause of this Ordinance should be declared invalid or unenforceable, such invalidity or defect shall not affect the remaining sections, paragraphs, parts, sentences, or clauses hereof and, to this end, the several provisions hereof are hereby declared to be severable.

SECTION 3. All Ordinances or parts thereof in conflict herewith are hereby repealed.

SECTION 4. This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

SECTION 5. This Ordinance was then submitted to an official vote as a whole, the vote thereon being as follows:
